Title	Chair of Webinar, Honorary Associate Professor, Australian National University
Bio	Honorary Associate Professor Julie Smith (B Ec (Hons)/B A (Asian Studies), PhD) is an awarded Australian Research Council Future Fellow at the Research School of Population Health, Australian National University. She is also a Fellow of the Tax and Transfer Policy Institute at the ANU Crawford School of Public Policy. Previously she held ARC and NHMRC funded appointments at the School of Regulation and Global Governance (Regnet), and the Australian Centre for Economic Research on Health (ACERH). Her research focusses on gender analysis, taxation policy, and economic aspects of breastfeeding, with more than 45 peer reviewed articles, book chapters and books. She has been an expert advisor to the World Health Organization and the US Department of Health and Human Services, the Australian Department of Health, and to national and international NGOs including ACOSS, UNICEF UK, IBFAN, and WABA. She is a co-founder of WBTi Australia, and a former director of the Australian Breastfeeding Association. Previously, she was a senior economist in the Australian and New Zealand treasuries and the Parliamentary Research Service in Canberra.

Bio	Naomi Hull is a Registered Nurse, an IBCLC and has a Masters of Public Health (nutrition) and currently the Co-ordinator of the World Breastfeeding Trends Initiative Australian team. Her passion for breastfeeding and lactation began after the birth of her first child in 2001. She became a volunteer Breastfeeding Counsellor in 2006 with the Australian Breastfeeding Association and recently completed a five-year term as the Qld Branch president. During her Masters of Public Health, her interest in the 'bigger picture' grew stronger and for this reason chose to look at the implementation of the Australian National Breastfeeding Strategy (2010-2015) as the topic of her Dissertation. This then led onto her current work, which involved using the World Breastfeeding Trends initiative tool to benchmark Australia's policies and programs on infant feeding. Naomi feels strongly about finding a way to ensure the protection and fulfilment of the rights of women and children to access information and support of health and nutrition.

Title	Global Advisor on Infant and Young Child Feeding in Emergencies, Save the Children
Bio	Alessandro Iellamo is the current global adviser on Infant and Young Child Feeding in Emergencies for the Save the Children Movement. He has an extensive expertise in infant and young child feeding (IYCF) policies and practices, particularly in emergencies, and on the WHO International Code and other global tools. Previous engagements included working with UNICEF and WHO. He has worked with the WHO's Scientific and Technical Advisory Group (STAG) on the International Code, and has been involved in developing the World Breastfeeding Trends Initiative (WBTi) and IYCF policy tools with the International Baby Food Action Network in Asia. He has also been involved in research on IYCF policies, practices and programmes, including work environments, International Code implementation, and financial aspects of the WHO/UNICEF Global Strategy on IYCF. His expertise on IYCF and IYCF-E having supported African, Middle East and South East Asia. Recently he has been engaged with IYCF and IYCF-E related policies issue also in high income countries, like Italy, Australia and Japan. He supported emergency responses, policies and capacity building and translating the IYCF Global Strategy and the IYCF-E operational guidance into national policies, preparedness plans and training packages. He is currently representing Save the Children in the steering committee of the Infant Feeding in Emergencies Core Group (IFE Core Group), the Nutrition and Food Security and Livelihood Interagency Technical Working Group, and the Global Technical Advisory Mechanism of Information and Assessments.

Bio	Rachel lives and works in Bangkok, Thailand and is a legal and policy consultant at UNICEF's Regional Office for East Asia and the Pacific. She has over 10 years' experience working on international legal issues related to food law, regulatory policy and consumer protection and is passionate about how innovation can transform the food system. At UNICEF, her work focuses on helping countries in Southeast Asia better implement, monitor and enforce the International Code of Marketing of Breast-milk Substitutes. Rachel has worked for a variety of international organizations including the United Nations, the Global Fund to Fight AIDS, Tuberculosis and Malaria, the Clinton Health Access Initiative, and Zipline - a Silicon Valley drone-delivery startup whose mission is to provide every human on Earth with instant access to vital medical supplies. Since 2020, she has been a Member of the Good Food Institute Asia-Pacific's Advisory Council. Rachel holds a Juris Doctor degree in Law from American University in Washington, D.C., and a Bachelor's degree in Political Science from the University of California, Los Angeles.

Bio	Hannah Dahlen is the Professor of Midwifery, Discipline Leader of Midwifery and Associate Dean (Research and Higher Degree Research) in the School of Nursing and Midwifery, Western Sydney University. She has been a midwife for 30 years and still practices. Hannah has over 200 published journal articles and book chapters and has strong national and international research partnerships. She has received 20 grants since 2000, including being a CI on three NHMRC grants and an ARC Linkage grant. She has spoken at over 100 national and international conferences in the past 5 years and given invited keynote addresses at most of these. In 2019 Hannah was awarded a Member (AM) of the Order of Australia (General Division) in the Queen's Birthday Honours list for her significant services to midwifery, nursing and medical education and research. Bio	Dr Karleen Gribble (BRurSc, PhD) is an Adjunct Associate Professor in the School of Nursing and Midwifery at Western Sydney University. Her research interests include children's rights, child-caregiver and caregiver-child attachment, parenting of children with a history of trauma, and the treatment of infants and young children within the child protection, immigration detention and criminal justice systems. She has published research on these subjects in peer-reviewed professional psychological, social work, and health journals and engaged in the training of health professionals, social workers, and humanitarian workers on these subjects. Karleen has written many reports for court regarding the breastfeeding rights and attachment needs of children whose mothers are interacting with the child protection or criminal justice systems. She is also an Australian Breastfeeding Association Community Educator and Counsellor.

Title	PhD Candidate, Australian National University
Bio	Libby Salmon (BVSc, MVS, Cert IV Breastfeeding Education) is a PhD candidate at the Menzies Centre for Health Governance, RegNet School of Regulation and Global Governance, Australian National University, researching regulatory regimes affecting women's food production for infants and young children through breastfeeding. Her research investigates the contribution of human milk sharing to infant food security and health policy in Australia. With qualifications and experience in agricultural and veterinary science policy and practice, Libby worked with Julie Smith from 2013 as a research associate at the Australian Centre for Economic Research on Health at ANU on a study of breastfeeding and childcare, and rapid evidence reviews for WHO on marketing of breast milk substitutes and complementary foods and for the 2018 Australian National Breastfeeding Strategy.
